WHEN IT WAS NOT POSSIBLE FOR ARTISTS TO WORK ON THEIR COMMISSIONED PIECES TO CONVERT THEIR WORK TO DIGITAL FORMATS, ODC THEATER REDEVELOPED ITS PRESENTING CALENDAR FOR 2021 AND 2022 TO ACCOMMODATE THE TIMING AND CREATIVE NEEDS OF THESE ARTISTS. ODC WORKED WITH THESE ARTISTS THROUGH 2020 AND WILL CONTINUE TO DO SO PAST THE ORIGINAL RESIDENCY CONCLUSION IF/AS NEEDED TO ENSURE THAT EACH MEMBER HAS MEANINGFUL ACCESS TO ART-MAKING AND PERFORMANCE SPACE, THE ABILITY TO PARTICIPATE IN A CHOREOGRAPHIC RESPONSE TEAM, CAPACITY BUILDING/ADMINISTRATIVE MENTORSHIP, THE OPPORTUNITY TO HOST AN ADMINISTRATIVE FELLOW AND COMPENSATED PARTICIPATION IN AN ANNUAL RETREAT, AND TECHNICAL RESIDENCIES AND PREVIEW PERFORMANCES (OR BROADCASTS). IN ANY YEAR, THESE OPPORTUNITIES CONSTITUTE IMPORTANT SUPPORT AT EVERY LEVEL OF THE CREATIVE PROCESS AND ARE DESIGNED TO PROMOTE LONG-TERM CAPACITY, RESILIENCE, AND SUSTAINABILITY. IN 2020, THESE CONCEPTS TOOK ON A FUNDAMENTAL NEW MEANING AND URGENCY. ODC THEATER'S COMMITMENT TO FULFILL BOTH THE INTENTION OF THE RESIDENCIES AND DELIVER ITS KEY COMPONENTS WAS A PROFOUND ACHIEVEMENT IN THE FACE OF EXTREME ORGANIZATIONAL UNCERTAINTY.

IN 2020, ODC WAS ALSO ABLE TO MAINTAIN ITS COMMITMENT TO RETAIN SIMA BELMAR, AS ITS WRITER-IN-RESIDENCE (WIR) AS SHE EMBARKED ON HER SECOND YEAR IN THE ROLE. ODC THEATER'S WIR IS CHARGED WITH PROVIDING INSIGHT INTO SPECIFIC WORKS AND A FRAMEWORK FOR CONTEMPORARY DANCE AND ITS CONNECTION TO BROADER SOCIAL/CULTURAL MILIEU,

WITH PERFORMANCE AND NEARLY ALL IN-PERSON DANCE ACTIVITIES PROHIBITED, ODC THEATER DEVELOPED AN INNOVATIVE LIVE-STREAMED BROADCAST PROGRAM TITLED, "THIS IS ALSO THE ART." THE SERIES INVITES THE PUBLIC TO, "MEET THE ARTIST. THE WORK. THE PROCESS." BY JOINING A LIVELY, INTERACTIVE, AND STREAMED CONVERSATION BETWEEN ARTISTS AND COLLABORATORS AS THEY GIVE A GLIMPSE INTO THE PROCESS OF THEIR WORKS IN THE LIMINAL TIMES AND SPACES BETWEEN PERFORMANCES. PARTICIPANTS AND AUDIENCE IN THE SERIES ACCESS CREATIVE CONTENT IN VARIOUS STAGES OF DEVELOPMENT AND HAVE OPPORTUNITIES TO ASK QUESTIONS ABOUT HOW A PERFORMANCE PIECE LIVES ON - OFFSTAGE.

WITH "THIS IS ALSO THE ART" ODC THEATER HELPED NOT ONLY TO CONTINUE TO SHOWCASE AND ENGAGE DANCE ARTISTS, BUT ALSO TO DEEPEN AUDIENCE ENGAGEMENT AND UNDERSTANDING IN THE ARTISTIC PROCESS AND IN THE CREATIVE LIFE CYCLE OF DANCE WORKS. BOTH OUTCOMES WILL BE FUNDAMENTALLY IMPORTANT TO THE RESILIENCE AND RE-EMERGENCE OF LIVE PERFORMANCE WORK AND ATTENDANCE IN THE BAY AREA ARTS ECO-SYSTEM WHEN IT ATTEMPTS TO NAVIGATE THE
